1. Que la medida tomada y publicada en la resolución 0001.2019; son medidas disciplinarias extremas pero necesarias por la gravedad de los hechos.
2. Que dichas medidas afectan a un grupo de personas que podrían haber basado sus decisiones en un conjunto de tendenciosas manipulaciones de las informaciones, lineamientos, preceptos y tradiciones de esta religión y del propio Código Odugbemi, así como de los mensajes y legados de nuestro difunto Arabà Odugbemi Lineage Chief Oluwo Oloye Ifashade Odugbemi (Ibae).
3. Que será condición "sine qua non", sin cuestionamiento, para el mantenimiento, tanto de su condición de Odugbemi, la publicación en sus redes sociales del apoyo a las resoluciones tomadas, así como su manifestación de ratificación y fidelidad a este linaje, a su Consejo Superior de Sacerdotes Mayores y a la figura de su Arabà Odugbemi Lineage Chief Oluwo Oloye Ifadare Odugbemi, en carta enviada a la dirección de correo electrónico, oluwoifadareodugbemi@gmail.com.
4. Que todo aquel que no acate estas condiciones será considerado de manera inmediata fuera del Linaje.
5. En relación a aquellos individuos que de manera unipersonal, o por indicación de la hasta hoy, Yeye Araba Iyaonifa Ifaleti Odugbemi (Sara Calabuig), después de haber sido apartados en su día del linaje, volvieron a presentarse como miembros del mismo, e incluso a hacer llamados públicos, nombramientos de egbes o convocatorias, indicarles que la palabra de este Consejo y de su Arabà, sea quien sea, siempre es firme y queda registrada en el cielo y marcada en la tierra, **son y seguirán siendo elementos expulsados del Linaje** y no autorizados a la utilización del apellido **Odugbemi**

Nuestro deseo es mantener el respeto, la integridad, la honorabilidad y el buen nombre de este linaje, y haremos todo lo que sea necesario para ello.

RESOLUTION 0006.2019

At an extraordinary meeting held between the **Odugbemi Disciplinary Council in Nigeria** and who subscribes the present **Arabà Odugbemi Lineage Chief Oluwo Oloye Ifadare Odugbemi**, we state:

1. That the measures taken and published in resolutions 0001.2019; 0002.2019; 0003.2019; 0004.2019 and 0005.2019, are extreme disciplinary measures but necessary because of the seriousness of the facts.
2. That these measures affect a group of people who could have based their decisions on a set of tendentious manipulations of the information, guidelines, precepts and traditions of this religion and of the Codex Odugbemi itself, as well as the messages and legacies of our deceased **Arabà Odugbemi Lineage Chief Oluwo Oloye Ifadare Odugbemi (Ibae)**.
3. That it will be a condition "**sine qua non**", without question, for the maintenance, both of its status as **Odugbemi**, as of its initiations and consecrated levels, the publication in its social networks of support for the resolutions taken, as well as its manifestation of ratification and fidelity to this lineage, to its Higher Council of Priests and to the figure of its **Arabà Odugbemi Lineage Chief Oluwo Oloye Ifadare Odugbemi**, in a letter sent to the e-mail address, oluwoifadareodugbemi@gmail.com.
4. That anyone who does not abide by these conditions will be considered immediately outside the lineage, but their initiatory conditions will be respected.
5. In relation to those individuals who, in a unipersonal manner, or at the direction of the present, **Iya onifa leti Odugbemi (Sara Calabuig)**, after having been separated from the lineage in their day, resubmitted as members of the same, and even make public calls, appointments of egbeso calls, tell them that the word of this Council and its **Arabà**, who ever it is always firm and is registered in heaven and marked one earth, **they are and will continue to be expelled elements of the Lineage**, and don't authorize for use the common name **Odugbemi**.

Our desire is to maintain the respect, integrity, honesty and good name of this lineage, and we will do everything necessary to do so.
